THE 135th ANNUAL MEETING Trinity Lutheran Church, Madison, South Dakota Sunday, January 23, 2022

President Rob Thuringer called the 135th Trinity Lutheran Church Annual Meeting to order at 12:00 p.m. He declared a quorum present.

President Thuringer presented the Adoption of Rules:

- 1. Please extend courtesy to all when speaking at the microphones.
- 2. Unless otherwise determined by a majority vote of the assembly, all speeches during discussion hall be limited to two minutes.
- 3. A speaker on one side of the question shall be followed by a speaker on the other side.

Pastor Bob Hansen led the congregation in the prayer of good courage from the Annual Congregational Meeting Opening Liturgy.

The minutes of the 134th Annual Meeting, January 24, 2021, were presented. Motion by Pat Engebretson, seconded by Jennifer Briggs, to approve the minutes as presented. Motion carried.

President Rob Thuringer announced that the reports would be considered in groups, and called for approval of Reports A (President Rob Thuringer), C (Deacon Suzanne Hansen, Interim Faith Formation Director), D (Auditor, Rachael Jencks), and F (Financial, Katie Nelson). Motion to approve these reports made by Danny Brown and seconded by Bridget VanLiere. Motion carried.

Pastor Robert Hansen called attention to his printed report (B) reminding the congregation that money follows mission and challenged the congregation to remember that everything we do is in response to what God has done for us. In the time that he has been at Trinity, he has focused attention on updating the church database. The Parochial Report 2021 reflects his efforts. The membership database is updated and more relevant than before, but will require continued effort to bring it up-to-date and keep it current. He suggested that the congregation also needs to review Trinity's constitution. Motion by Ann Marie Rossing, seconded by Wade Briggs, to accept Pastor Hansen's report. Motion carried.

Motion carried.

President Rob Thuringer presented the 2022 Mission Plan. He pointed out that the 2022 Mission Plan is smaller than previous plans. This plan offsets some expenses using money in appropriate savings and is a more realistic projection of income and expenses. Motion by Lori Schultz, seconded by Susan Farrell-Poncelet, to approve the 2022 Mission Plan. Discussion of the plan followed. Rick Schmidt expressed concern about the percentage of the total plan that is devoted to staff compensation. Lori Schultz made the observation that there are no savings offsets available for compensation. Arleen Weerheim expressed gratitude for the effort to present a Mission Plan with more realistic numbers than in the past. Jim Iverson explained that the line item for compensation actually includes more than wages and salaries for the Trinity. Also included are insurance and retirement benefits, continuing education for the pastor, housing allowance. Pastor Hansen explained that when the call committee comes to the Council, and to the congregation, with a plan for hiring a new pastor, they will have all the number for compensation for the candidate. Those numbers will be based on the South Dakota Synod's guidelines. Motion to approve the 2022 Mission Plan carried.

There was an error in an earlier action. Report D. Auditor—Rachael Jencks was not included in the packet. Motion by Danny Brown, seconded by Jennifer Briggs, to remove the auditor's report as approved. Motion carried.

President Rob Thuringer introduced the council's recommendation that the church car be declared surplus and sold. The car was purchased when the Hagmaiers arrived. The intention was to save money on the pastors' mileage expense. Motion by Jim Iverson, seconded by Jean Mitchell, to declare the church car surplus and to sell the car. Motion carried.

Under other business President Rob Thuringer gave a report from the Call Committee. He, Ann Marie Rossing, Stacey Riedel, Sandy Cole, Mallory Schultz, Erica Anderson and Marie Millage serve on the committee. They have had multiple meetings with one candidate and will continue with the process as defined by synod guidelines. Pastor Hansen explained that the process is confidential until a candidate is proposed to the church council.

Dick Ellis suggested an option to reduce the congregation's long-term debt. He suggested that the congregation consider paying off the debt with money from the Trinity Foundation and repay the Foundation the amount that we would be paying the bank. The interest on the loan is 4.25%. The Foundation has funds invested in the ELCA Endowment Pooled Trust which earned about 10% last year. No action was taken. Pastor Hansen mentioned another option which would borrow the money to pay off the loan from the members of the congregation. No action was taken. President Rob Thuringer stated that the congregation had made progress in paying down the principle of the loan in 2022. 51% of the loan has been repaid leaving a balance of \$301,200.

President Rob Thuringer thanked Pastor Bob and Deacon Suzanne for their service and expressed his gratitude to the members of the council for their diligence in the past year. He introduced Danny Brown, incoming president.

Danny Brown thanked President Rob Thuringer for his leadership. He also expressed his thanks to the Hansens and to everyone who works to promote the mission of Trinity.

There being no additional business to come before the meeting, President Danny Brown called for a motion to adjourn. Motion to adjourn made by Pat Engebretson, seconded by Jennifer Briggs. Motion carried.

REV. STEVEN LINDLEY'S ANNUAL REPORT

Overview

2022 was a year of transition for all of us at Trinity Lutheran Church. My family and I purchased a house for the first time in twenty years and moved to a new town, in a different state. We have adapted to new calls, new schools, and a new church family, while learning how to properly pronounce "Pierre" and trying new foods like chislic. Now that we are (mostly) settled in, we are genuinely enjoying Madison, our new home. Each of our kids has found their niche in the schools and activities, and have made a good group of friends. We have discovered lots of fun things to do in Madison and the surrounding areas. And, the people here have been wonderful! Change is difficult, but this transition was definitely made more manageable by the unbelievable outpouring of love, support, and hospitality we received from the people of Trinity.

At the same time, this community of faith has continued in what has now been years of transition. After years of excellent, stable leadership, Trinity has endured several years of fluctuation and uncertainty in our pastoral leadership and staff. With the help of some really solid lay leadership and the guidance of several interim pastors, this faith community made it out of that time of limbo, and then, this crazy family from Wisconsin showed up. Over the last few months, we have been working to get to



know one another and learn how to work together. In the midst of this, the Holy Spirit is stirring up some really cool and exciting ministry opportunities among the people of Trinity.

I am filled with gratitude, as I reflect on our first five months in ministry together and as I imagine the awesome things God will do in and through us in the years to come. Thank you for calling me and my family to walk alongside you in ministry. Thank you for enthusiastically welcoming us with open arms. And, thank you for the patience and grace you have offered us, as we have gotten settled and worked to learn the ropes here at Trinity!

Administration of Office and Staff

We are blessed with a dedicated, hard-working, faithful team. The Trinity staff has welcomed Deacon Koren and I in, helped us to get settled and get our bearings, and educated us on some of the history and traditions of this faith community. They are eager to help wherever they can and do what needs to be done to keep things running smoothly.

It took a couple months for us to get to know each other, to discover what each of our roles is, and to gain awareness of what each staff member's gifts and passions are. I feel like we have gotten into a good rhythm and are starting to work well together. I also appreciate that our work is grounded in prayer and we are able to have some fun, even when things are busy and stressful.

In late-November, we had our annual staff affirmations. These conversations were a great time to show appreciation and thank the staff for the excellent work they are doing. It also gave us an opportunity to hear from each of the staff members what they feel is going well and what needs they have, at this time. I am grateful we have this process in place, and now that I've been through one, I have a better idea of what my role is and I have some ideas on how we can facilitate these more efficiently and effectively, in the future.

Preaching and Worship

Since every faith community has their own unique styles, patterns, and traditions in their worship life, it took me a little while to adjust to leading worship here at Trinity. And then, just I was beginning to feel more comfortable, we switched to the fall worship schedule and I needed to adapt again. I have, once again, become more at ease with worship leadership here and feel good about how things are going in



this area of our ministry. I think we have done a pretty good job of making space for the sacred and holy, while at the same time, creating an environment that is relaxed and accessible for people of all ages and backgrounds.

We have heard from several people that we need to keep the length of our worship services as close to an hour as possible. In response to this, we have cut out a few parts that would traditionally be included in worship. Our hope is that we can continue to create a meaningful worship environment, while honoring the feedback we have received from folks.

I truly appreciate that Trinity is a community of faith that gives helpful feedback to the preacher. It has been good to hear from people how the messages have spoken to them – what has been meaningful, challenging, and uplifting. Preaching is a curious endeavor. You never really know how your words will be heard and how the Holy Spirit will be moving during that time. So, I find that hearing people's thoughts is invaluable, as I prepare for the next week.

Spiritual Formation

• Confirmation: There have been some growing pains for us, as we learn how to adapt our Confirmation philosophy and practices to a group of students almost ten-times the size of what we have had in the past. That said, I am happy with how things are going in Confirmation this year. Our main focus has been teaching the kids about prayer and introducing them to different prayer practices; giving them the opportunity to try them out and see which practices work for them and which do not.

We also engaged in an awesome service project through *Samaritan's Purse*. The kids collected



various items (toys, writing/drawing materials, personal care items, etc) and packed them in boxes to be shipped out to people in need, all around the world. I believe this activity was a highlight for most of the students. They had tremendous energy and excitement throughout the planning, preparation, and implementation of the project. Thank you to Diane Bruns for her vision and leadership with this project, and to her husband, Bill, for all of his assistance, along the way!

Once we get into the new year, there actually is not much Confirmation left because we have Lent in there, as well. We will devote much of those last few weeks to the kids' spiritual practice projects, and the 8th graders writing their faith statements and choosing mentors. It is always rewarding to see the students start to make their faith their own and learn how to share it with others.

 High School Youth Group: It has been a joy to have the opportunity to work with these young men and women each week. Every week looks a little different, but our main focus has been building relationships, talking about our faith, and having fun. We are also trying to give the youth opportunities to get out and enjoy one another, outside of Wednesday evenings. In addition, the high school youth have already helped with a number of service projects this year and we have a few more coming up.

Men's Ministry: In October, four men from Trinity made the trek down to Camp Carol Joy Holling outside of Ashland, Nebraska, for Lutheran Men in Mission's national Bold Gathering. This event was a great time of connecting with other men of faith – learning, serving, and worshiping together. Out of this, the men who participated began to wonder what other ministry opportunities we might offer to the men of Trinity.

In November, we began hosting a monthly men's gathering at The Office downtown. These gatherings have given men a chance to get together, have some good food, drink, and conversation, and to talk about how our faith impacts our lives. So far, we have had a great turnout and I am pleased with how these have gone. I look forward to seeing how the Spirit continues to work in our men's ministry at Trinity.

• *Table Conversations*: There were three opportunities for Trinity mission partners to gather

around the table, to get to know one another better, to talk about what is important to them, and to dream, a little, about what God might be up to in this season at Trinity. I really enjoyed and appreciated these conversations. I was able to learn more about the people who participated, hear their stories, and make connections I would not have otherwise made. We definitely need to reschedule one Table Conversation that needed to be postponed, but I also think it would be worth revisiting this idea again in 2023.

Pastoral Care

It is truly an honor and a gift to be called to walk with the people of Trinity in all this life holds for us – the good and bad, joy and pain. Thank you for trusting me in all the hills and valleys you experience. It is a privilege to get to hear your stories, to pray with you, and to remind you of Christ's loving, healing, redeeming, unending presence with you, through it all. Thank you for sharing your lives with me!

Outlook

Franciscan priest, theologian, and writer, Richard Rohr, has said, "... many religious folks insist on answers that are always true. We love closure, resolution and clarity, while thinking that we are people of 'faith'! How strange that the very word 'faith' has come to mean its exact opposite." Looking ahead to 2023, the only thing I can say with certainty is, "I don't know." I don't know what the year will hold for us. I don't know what kinds of ministry God is calling us to. I don't know what adventures Jesus will invite us into. But, I do trust that the Holy Spirit has brought us together in this particular time and place, to collectively discern God's mission for us, and to use all of our gifts and passions to be Christ's body







in Madison and beyond. I trust that God is here with us, pouring out his creative love and grace on us, preparing us for whatever he has in store for us. I am grateful and excited to be on this journey with you!

FOUNDATION COMMISSION ANNUAL REPORT - 2022

The purpose of the Trinity Lutheran Church Foundation is to help fulfill the mission of Trinity in all of its activities. The duties and responsibilities of the Foundation Commission are set forth in Trinity's Constitution and the Foundation's policies and procedures, and include the following: (1) to receive and acknowledge all gifts received by Trinity that are not designated for current operations or other special fundraising efforts, (2) to invest, manage and disburse all gifts and managed funds, (3) to encourage the giving of special gifts; (4) to provide annual education about planned giving and estate planning and (5) to celebrate gifts given through recognition programs developed by the Foundation.

The Foundation Commission manages several endowment funds and uses income from these endowed funds for benevolent purposes to further Trinity's missions and ministries. In 2022, the Foundation approved the following uses of income from the endowment funds:

- <u>The Faith In Action Endowment Fund</u> is to assist many ministries within Trinity and other areas.
 - \$1,000.00 A spring 2023 Women's Retreat
 - \$ 650.00 Scrapbooks to preserve confirmation pictures
 - \$ 362.75 Supplies to preserve contents of the vault
 - \$ 500.00 Supplies for Days for Girls Project
 - \$ 500.00 Magnetic Whiteboard for Trinity Preschool
 - \$2,000.00 Kids Against Hunger
- The <u>Camp Counselor Scholarship Endowment Fund</u> was not awarded this year due to no congregational members meeting all of the requirements set up for the endowment.
- The <u>Edwin Hanneman Missionary Endowment Fund</u>. This fund continues to provide support for missionaries working with the ELCA Division of Global Missions. The generous gift of Mr. Hanneman through his estate allows our congregation to support God's work through these missionaries. The missionary we supported for 2022 was Pastor Stephen Deal (Costa Rica). The total gift of \$5,660.
- The Hazel Johnson Mission Endowment Fund.

\$1,200 of Hazel Johnson Endowment Fund grant was awarded to Mark and Rose Jensen for their work with translations of the Bible.
\$1,038 of the Hazel Johnson Endowment was awarded to Kids Against Hunger. Submitted by Scott Parsley and Steve Lindley.

- There was no **Seminary Scholarship Endowment Fund** award for 2022.
- \$665 of income from the **Rasmussen Organ Maintenance Fund** was transferred to Trinity Lutheran Church to offset some of the expenses of maintaining our beautiful pipe organ.
- The Board of Trustees and Church Council received \$3,475 of income from the <u>Cornerstone Endowed Fund</u> to their Cornerstone Fund for use for capital improvements, major repairs, equipment and any other physical needs of the facilities owned by Trinity Lutheran Church.

Endowment Balances. As end of the year statements had not been received as of the deadline for this annual report, the following endowment fund balances were under Foundation management as of September 30, 2022. The spending policy for each of the endowments were established in 2005 or at the time the endowment was received by the Foundation. The spending policy specifies that only the earnings shall be used not the principal amount. The balances have not been adjusted for the current year expenditures since they will happen in quarter 4 of 2022.

The Total Current Assets of the Trinity Lutheran Church Foundation as of 9/30/2022 are \$774,466.85. Total Current Assets as of 12/31/2021 were \$970,903.33.

Additional future assets of the Foundation include one life insurance policy and two certificates of deposit. These future assets had a market value of \$12,817.28 as of September 30, 2022.

Trinity was remembered with many 48 memorial gifts during the year. A total of \$7,651 as of November 1, 2022 was received. The "I Am In" campaign and Campership received several gifts. If memorials are not designated by the donor for a specific project, they are distributed according to the Foundation distribution policy that gives the Cornerstone 50% of the gift, 25% to the Deacons and 25% to the Parish Education programs.

The Foundation endowment funds would not exist without the generous gifts that have come from our members. Our Legacy Leaders plaque in the Narthex recognizes those individuals (1) who have left a gift to Trinity through their estate, (2) individuals who have notified the Foundation that Trinity has been included in their estate plan, or (3) individuals who give a gift of \$1,000 or more to one of the Foundation endowment funds. We do encourage <u>everyone</u> to consider including Trinity in your own estate plan. Members considering a gift should consult with an attorney or financial advisor for personal financial advice.

The Foundation did their annual education event with two of the Faith In Action recipients giving a Temple talk during both worship services as well as doing a brief meet and greet during the coffee hour. Jona Schmidt represented Bethel Lutheran Home and Lou Crockett presented on behalf of Family Connection.

January 2022

- New lights have been installed. The bill totaled \$7612.22 with a rebate of \$2150. The board approved payment of the bill.

May 2022

Life and Growth

Coffee hour was held throughout the year with service groups providing the treats and serving. Coffee hours were held in between services (around 9:45 am) during the school year and after the 9:30 am church service in the summer. Letters to service group members were sent the month prior to them serving to allow them to plan for the coffee hours. Special celebrations during coffee hour in 2022 included some receptions and celebrations.

In May, we honored the high school graduates. In July, we served cake to thank Pastor Bob and Deacon Suzanne Hansen for their time in serving us in their Interim ministry. In August, we had a reception for the installation of Pastor Steven Lindley, and the council served cake at the coffee hour. Lenten Soup Suppers were held on Wednesday evenings during the Lenten Season. Service groups were split up among the weeks to provide food and serve. Due to the reduction of service groups last year, the number of volunteers each week was stretched a little thin. Campbell's Chicken Noodle still remains a favorite with the young people. Jelly sandwiches were served along with sliced bread, carrots, celery, vegetable dip, and crackers.

Cookies and bars were provided by the confirmation students and their families. Confirmation students also helped each week with clearing and wiping down tables. The attendance each week for the Lenten Soup Suppers showed that these suppers are a favorite where attendees can enjoy a variety of wonderful homemade soups. Letters were sent to all new members throughout the year informing them to which Faith Family they were assigned.

The 2022 Confirmands was honored in between services on October 30th with a cake reception.

Mission Momentum

Our worship services were again live-streamed and recorded this year and we saw declining members attend either Sunday service, and we hope they were able to view our services at home. We want to thank Kaden Krusemark, Bob Gale, and Steve Millage for their service to Trinity in 2022.

We identified a specific mission for each month of 2022, and they were:

We highlighted each ministry throughout the year through the bulletin announcements, weekly emails and monthly newsletters inviting our members to contribute to any program by giving a gift to Trinity identified for a specific program. Last year, we put \$4,000 in our mission plan for these twelve ministries, and our members contributed over \$2,000, which cut our total cost by half in 2022.

On August 29th, we served 217 carryout meals at *The Gathering*, and applied for a grant through the United Methodist Church, which helped to reduce our final cost. The meals were catered by Nicky's. The war in Ukraine began this year, and the ELCA encouraged all congregations of the Church to send in donations to the *Lutheran Disaster Response* and the ELCA began sending donated funds to help the Ukrainian people impacted by this war.

Sacraments and Services

There were three main areas that I coordinated within Trinity this past year -

Home Communion

We have five members of our Trinity family who receive home communion on the third Sunday of each month. I call these folks to check on their health condition, and if they would like communion brought to them the upcoming Sunday. I then email the volunteers and arrange for the communion delivery that Sunday. Each month, I call into the office and let them know who volunteered that month, and they are recognized for their service. As I leave my position today, I do want to thank Tom & Joyce Farrell, Ron & Bobbi Janke, Roger & Nancy Moose, David & Ann Marie Rossing, and Susan Williams for their dedicated service in the past three years I worked with them.

The Trinity "Loafers"

In April, Pastor Hanson said it was time that we moved away from our COVID thinking, and return to using home made bread as part of the elements used in Holy Communion. I want to thank Jennifer Briggs who offered to bake bread for April & May. I emailed our list of Trinity "loafers" with the specific dates we would need home made bread prepared and ready for either the first Saturday service or the service(s) on the first and third Sundays. I chose to make a scheduled list beginning in June and going to June of 2023. Within 48 hours of my email – the list was filled with volunteers! My heart was overflowing with gratitude for their response. Thank you! In October, Pastor Lindley asked if we could begin offering Holy Communion on the fifth Sunday as well. I contacted our October "loafer" and this practice began on Reformation Sunday, October 30th. Our volunteers will need to add a fifth Sunday to their 2023 months – for this January, and then April, July, October and December.

Pulpit Supply/Worship Leader

With our Interim Pastor and Deacon Suzanne living in Brandon, SD, and being part-time, I knew that more work would fall to may of us in providing worship leaders and perhaps pulpit supply as long as they were serving in their interim positions. In July, Pastor Bob and I met to plan where he would be unavailable to provide worship leadership and preaching. He asked if I would do the Saturday communion service once a month and had contacted Synod Bishop Hagmaier for her authorization to allow me to preside over the Holy Communion service for these evening services. They must have had quite a visit, because Bishop Constanze emailed me with the authorization to preside over any communion service during the time Interim Pastor Hanson was here. Last year, I did five Saturday

services and five Sunday services where communion was part of the worship service. I also want to thank Ann Marie Rossing who led three Sunday services and preached last year, and to Deacon Koren who preached last October.

Special thanks to Lisa Gale for lining up communion assistants throughout the year!

2022 BOARD OF EDUCATION ANNUAL REPORT

We were grateful to have two wonderful Deacons serve Trinity's Faith Formation programs this past year - Deacon Suzanne Hansen and Deacon Koren Lindley. They have been a true blessing in moving the faith formation programs forward.

January – Bingo Bash was scheduled for January 30th – but weather caused a couple of postponements and finally we had to cancel the event – hoping for better luck in 2023!

Trinity Lutheran Preschool - Fall 2022 Enrollment - open to Trinity Members only until March.

February – Preparations for Lenten soup suppers began with the confirmation students to serve as ushers / acolytes / and help with soup supper clean up. The National Youth Gathering was canceled and money refunded to those students who were planning on going. HS youth leaders will look for another opportunity for the summer.

March – First communion instruction was offered to 3rd – 5th grade students during the Sunday school hour. Students painted chalices to use for their first communion.

Trinity Lutheran Preschool - Fall 2022 Enrollment - is now open to the public.

April - Easter Sunrise breakfast was served by the HS youth. On April 14, 27 children received their first communion. The Board decided to make \$200 camperships available to all TLC youth attending any summer camps. On April 24, 17 Trinity seniors were presented a quilt made by the Trinity Piece Makers as a blessing for their upcoming graduation from High School.

May – The last day of Sunday School was May 1st and celebrated with a Sundae Sunday event complete with ice cream sundaes and toppings. A donation was made to the Madison High School Baccalaureate committee for their upcoming program and blessing for the seniors. The HS youth have decided to attend the Pine Ridge Immersion Experience program July 10-17.

June – We welcomed Valerie Wilkens to the Board Of Education, serving the MS youth and confirmation program. St John Lutheran will be hosting a Day Camp and opened their doors to TLC kids who would like to attend.

July – The HS Trip to Pine Ridge was canceled due to lack of participants. TLC sent eight kids to the Day camp experience at St John Lutheran. Board of Ed conducted an interview with Deacon Koren Lindley and voted unanimously to hire her as the Faith Formation Director.

August – Deacon Koren Lindley started her position on August 22. Pastor Steve is working on Confirmation programming and details sent to parents in preparation for start dates.

September – Rally Sunday was held on the 11th with the Backpack Blessing. Children in Preschool 1 -5th grade attend classes on Sunday mornings from 10:00-10:45. There are 84 children registered for Sunday School and 21 teachers/helpers assisting. We shifted over to the lectionary-based curriculum by Sparkhouse and have a digital subscription rather than buying books. Changes were made to the structure of confirmation in 2021 and we continued this year with students in grades 6th, 7th, and 8th attending confirmation classes each Wednesday from 5:30-6:30pm. Pastor Steve and

Deacon Koren have been leading the classes. We have 49 students and 10 adult guides leading 8 small groups.

High School youth group kicked off the year with a pizza planning party. We had 40+ youth in attendance.

On September 29th, Jennifer Briggs, along with her daughter, Ashley, and 6 Trinity youth volunteered at Feeding South Dakota in Sioux Falls. They did various tasks including working with produce - picking through 600 cauliflower heads, repacking 40 pound onion bags into 3 lb units, repacking 10 lb potato bags into 5 lb units, sorting through bags of carrots, and cutting netting for the next group of volunteers bagging efforts. The kids had a good time and were excellent volunteers!

October – On Sunday, October 30th our 9th graders were confirmed at the service of their choice. Pastor Steve led the service for the 23 young adults.

Jennifer Briggs and Angel Bruna handed out Smarties & God Loves you stickers at the Madison downtown trick or treat event. We had the HS youth wrap the smarties with a TLC sticker with our website and service information. We handed out nearly 500.

November – Our 6th, 7th, and 8th grade Confirmation classes participated in the Operation Christmas Child group project. It was a heartwarming, faith in action and fun project for our students. Together we blessed 111 children around the world with gifts of love and the story of Jesus. TLC donations of \$985 covered the cost of items for 50 boxes and their shipping costs. Doug and Joan Merager and Marv and Sandy Rhode each provided their \$250 Thrivent cards to cover shipping costs for another 50. Additional members of our church family filled 11 more boxes. Much thanks to Diane Bruns and the Confirmation Guides for embracing this opportunity.

Adult Bible study began with Deacon Koren and Ann Marie Rossing in the Fellowship Hall each Thursday, from 12-1pm, to discuss the upcoming readings for Sunday's worship.

ELCA World Hunger Advent Bible Studies began on November 27 with 3 offerings for those who would like to gather, Sunday morning during the SS hour, Thursday's with Ann Marie at noon, and Sunday evening at 6:30 at the Briggs' home.

The Hanging of the Greens Service on November 27th featured our SS children's choirs and we had good attendance despite not having SS that day as it was the weekend after Thanksgiving.

December – Kids' Christmas Worship on Sunday December 18th at the 11:00 service with the Sunday School students leading worship and celebrating the coming of the baby Jesus. The 5:00 p.m Christmas Eve service once again had the children dress up in costumes to represent animals, people, angels, wisemen, etc. for the Christmas Story.

Annual Report for Trinity Lutheran Preschool 2022

Trinity Lutheran Preschool is staffed by Beth Himley, who is in her second-year teaching at Trinity Lutheran Preschool. The preschool hired a new assistant teacher in August, Kendra Paulson. Miss Kendra helped in the preschool from August to December.

The children who were enrolled in the January through May sessions discovered polar animals, experienced Valentine's Day and what friendship means, visited the Lake County Museum, and Dairy Queen! The preschool had their own butterflies that the students could watch 5 butterflies metamorphosize. The students also planted their own clovers and witnessed how plants are nurtured. The students had their spring concert at the end of April and did a terrific job!

School began in August with 49 children enrolled. There are 24 students in the MWF classes and 25 in the TTH classes.

In September, the students learned about fall and participated in apple stamping with paint. In October, the classes took part in Fire Safety month. Fire Chief Randy Minnaert came to the preschool for the TTH classes and showed them the fire gear and a fire engine. The MWF classes were able to take a field trip to the Fire Station. The preschool also completed their second fundraiser with Gaylen's Gourmet Popcorn from Madison this fall. The fundraiser was a hit once again! In November the students made a Thankful tree where they stated what they were thankful for on each leaf of the tree! In December, the children learned about their five senses and why we celebrate Christmas. The MWF class made their own gingerbread houses from donations from the preschool families. We were not able to have our Christmas party or our Christmas program due to the weather. At the end of each month Miss Court, the children's librarian from the Public Library, came to read a few books to all the classes. The children love having her come and visit!

"As a community of women created in the name of God, called to discipleship in Jesus Christ and empowered by the Holy Spirit, we commit ourselves to grow in faith, affirm our gifts, support one another in our callings, engage in ministry and action, and promote healing and wholeness in the church, the society and the world."

All women of Trinity are included in the organization. We have circles that meet monthly for Bible study and fellowship and hope that Covid does not return to prevent our meeting as it did before.

Three Gatherings are normally held by the Medary conference. One in the Spring, Fall and early winter. Also the Annual meeting is during the year usually in the summer was held this year .

The efforts of the women of Trinity are the Mission Action projects. In 2022, there were 82 quilts sent to Lutheran World Relief and 98 quilts given locally/elsewhere including Trinity's graduating high school seniors, The Family Connection in Sioux Falls and the Madison School District to be given to students in need.

I am IN Capital Campaign Report

".. God loves a cheerful giver." 2 Corinthians 9:7

In February of 2018, with the blessing of the congregation at the Annual Meeting, we embarked on a \$1.5 million Capital Campaign to address the estimated \$1.6 million dollar building repairs we were facing. This was an opportunity for Trinity's family and friends, near and far, to respond to God's abundant generosity by making financial commitments over the next five years.

The Trinity faithful answered the call and pledged \$1,020,807. We are forever grateful for your generosity and commitment to the Capital Campaign. We have finished year 4 of the 5-year campaign and we have received nearly 93% of the total dollar amount pledged with the addition of non-pledge & anonymous cash gifts. To date there is a balance of \$188,555 in pledges yet to receive, with \$4,500 in forgiven pledges. By the numbers – we have received 89 fulfilled pledges + 38 gifts above their pledge; 68 non-pledge / anonymous cash gifts; and have 101 ongoing pledge payments and 13 zero-payment pledges.

At the beginning of 2022, our Mission Investment Fund (MIF) construction loan had an outstanding balance of \$301,200.26. The council decided to restructure the outstanding loan balance by using \$45,000 of Cornerstone savings, \$45,358.63 from the Tommerassen Estate investment, \$100,000 of Parsonage CDs, your generous principal only gifts, special offerings, memorials, and I am IN pledges. The MIF Loan has been paid in full but has not left us debt free.

The Parsonage CDs were redeemed on the condition that the \$100,000 be treated as an internal loan, whereby the Church would pay interest on the loan at 4% per year until paid. The I am IN capital campaign pledges received (above the amount needed to make the MIF loan payoff) allowed us to make a \$40,000 payment plus a \$4,000 interest payment applied to our internal loan for the year 2022. With your continued support and pledge contributions we anticipate being able to repay the internal loan in full in 2023. This restructure has eliminated a \$7,000.00 monthly loan payment. Thank you! Bethel Lutheran Home, Inc. - 2022 Congregation Report

Since Bethel Lutheran Home opened its doors on March 25, 1962, we have had the amazing opportunity to serve thousands of residents as an extension of your Church. You continue to bless us with good people, both by electing excellent delegates and by referring friends and family who need our services. We are so grateful for all that you do for Bethel Community!

Our 61st annual corporation meeting is scheduled to be held on January 24, 2023, to review the fiscal year end 2022 audited financial statement for Bethel Lutheran Home, Inc. This is the first year that we have held the Annual Meeting in the month of January due to nationwide staffing challenges impacting all facets of life. Typically, yearly audits are reviewed at the annual corporation meetings held in October.

I want to take a few moments to thank everyone for their renewed service to Bethel and our mission in Lake County. Your generous gifts, both monetary and valuable time, have made a dramatic improvement in the lives of the Residents, staff, and our "Community". Every one of you has profoundly impacted our lives and I truly want to say "Thank You" from the Bethel Community.

COVID-19 Impact at Bethel

Currently 53 of 54 Residents that reside at Bethel are vaccinated and approximately 96% of our staff are vaccinated. Bethel experienced it's third outbreak in December that caused 7 residents and 3 staff members to test positive for COVID-19. None of the vaccinated residents or vaccinated staff became very ill as a result which is a testament to the effectiveness of the new Bi-Valent vaccination.

COVID-19 remains factor that causing the most profound impact on staffing. Locating, hiring, and maintaining normal staffing numbers remains one of our largest challenges ending 2022 and entering 2023. We have had 5-6 open CNA positions since March 2021. CMS requires nursing facilities to maintain specific staffing levels. If the facility misses this benchmark, CMS can impose monetary penalties. To combat this, we utilize Agency staffing to fill open positions to maintain a census and provide quality care. The problem this presents is we must pay temp staffing companies approximately 50% more than we are able to pay our full-time and part-time staff. In fiscal year end 2022 we spent approximately \$430,000.

Decreased staffing numbers also affects the number of residents that we can effectively provide care for. Currently our census is on average 53 residents or 90% occupancy. It is important that the quality of care shouldn't be compromised to keep Bethel full. We will increase census as staffing allows. Bethel is among the top 10% of Long -Term Care facilities in South Dakota based on census, most facilities at this time average a 75%-85% occupancy.

CMS also establishes reimbursement rates for the services provided to our residents. Currently there is a \$63 dollar per day difference in the cost to deliver care versus the Medicaid reimbursement rate.

Operational Updates

Bethel's revenue has increased to \$6,632,460 compared to \$6,147,364 in 2021. Our Profitability, Activity and Efficiency (Return on Capital Employed) ratios have all decreased mainly due to our Agency staffing as well as current inflation rates. Working capital or the time to collect payments was 11.48 days in 2021 currently we are at 13.63 days in 2022. Our cash flow is positive currently at \$588,210 with our marginal cash flow at 100.69%. Currently our Debt level has decreased and currently sits at \$2,048,392. Bethel had an operating loss that can be related to contract labor (temp CNA staff).

Capital Improvements

The Derecho in May caused damage throughout the Bethel Community. We have repaired roofing damage on the Chapel, Assisted Living, Apartments, and the Patio Homes as well as removed numerous trees on the campus. The roof over the Bethel Home needs to be replaced as was stated in the 2021 report with a cost of approximately \$300K. Bethel applied for a grant to replace the existing HVAC system with an upgraded filtration system that will be compliant with new air quality standards and was awarded \$251,912. The contract was awarded to Barger Electric with the project beginning September 2022. So far, all new roof top HVAC units have been placed, the remaining work will be when the weather cooperates.

Technology Improvements

- In 2022 we did not improve any technology assets as Bethel was in a good position. In 2023 we will be dramatically improving our Cyber Security posture. Thanks to a grant through DSU we will be implementing a new VPN, Multi-Factor Authentication software among many other safeguards to ensure our resident information is secure. This grant will allow for our system to be actively scanned and defended by local vendors in Madison as well as the State of South Dakota. These services will be paid for in the year 2023 and potentially going forward depending on continued Federal Grant Funding.
- We will be installing a new PA system to allow for facility wide communication as our old system is no longer functioning and not able to be repaired.
- We are updating our Camera Security system by purchasing a new server as well as a new camera by the employee entrance. This system is over 10 years old and not able to be upgraded due to age

Additional Updates for FY 2022:

- Bethel Lutheran Home did file an RPA, Request for Public Assistance, with FEMA after the Derecho in May. Currently we have requested the cost of the debris removal to be reimbursed which is approximately \$33,000. When approved we should be reimbursed approximately 85% of the total costs.
- There is currently a very strong push in this legislative session for a 21% increase and rebase for Nursing Home Medicaid reimbursement. If/when this passes, I feel this will help alleviate some of the financial burden while potentially helping with recruitment and infrastructure needs. There have been an unprecedented number of Long-Term care closures since 2019 (16 total) with 7 in 2022 alone.

Star Rating

• Bethel Lutheran Home currently has a 3-star facility rating. 5 stars is the highest rating a facility can achieve. This rating is a snapshot in time of a nursing home's quality measures, which include infection rates, our ability to take care of our residents' pain levels, and quarterly staffing levels and annual survey results. In April 2019, CMS changed the criteria of its rating criteria which resulted in over 70% of nursing homes in the U.S. dropping a star rating.

Overview of challenges facing Bethel

- Medicaid reimbursement \$63 disparity from cost per day.
- CNA turnover rates and competition with staff agencies. Currently we pay a single Agency CNA at a significantly higher rate than our "organic" staff. This is a non-sustainable model; we are in drastic need for CNAs in Long-Term Care.
- Ability to pay competitive wages due to low Medicaid reimbursement.
- Capital improvements Bethel is getting older, and several updates are needed.
