THE 136th ANNUAL MEETING Trinity Lutheran Church, Madison, South Dakota Sunday, January 22, 2023

President Danny Brown called the 136th Annual Meeting of Trinity Lutheran Church to order at 12:10 p.m. A quorum was present.

President Danny Brown presented the Adoption of Rules:

- 1. Please extend courtesy to all when speaking at the microphones.
- 2. Unless otherwise determined by a majority vote of the assembly, all speeches during discussion shall be limited to two minutes.
- 3. A speaker on one side of the question shall be followed by a speaker on the other side.

Motion by Ann Marie Rossing, seconded by Jean Mitchell, to approve the agenda as printed. Motion carried.

Pastor Steven Lindley read from Matthew 4:22–25 which introduces Jesus' ministry of healing. He reminded the congregation that we are called to be healers today.

Motion by Jennifer Briggs, seconded by Tami Christiansen, to approve the minutes of the 135th annual meeting as printed. Motion carried.

Reports:

- A. President Danny Brown submitted a written report and thanked Trinity's staff, council, and congregation for their participation and work on behalf of Trinity. He is looking forward to a bright future for Trinity Lutheran.
- B. Pastor Steven Lindley submitted a written report and thanked the congregation for the welcome and continued support he and his family have received. He is grateful for all that is done to make ministry happen at Trinity and stated that God gives Trinity everything needed to be what it is called to be.
- C. Deacon Koren Lindley submitted a written report.
- D. President Danny Brown addressed the Balance Sheet in the Treasurer's Report. There is a balance of \$132,000 in the checking account. Last year was the first year that savings were used to balance the budget. \$65,000 was transferred from savings to the general fund. Of that total, \$16,000 was expended, and the remaining \$49,000 remains in the checking account.

The 2023 Mission Plan was presented by President Danny Brown. The plan anticipates \$380,000 in general offering. The highlighted items in the plan indicate which savings may be drawn on to meet the plan. If necessary, funds may be transferred from the Cornerstone Fund. Motion to approve the 2023 Mission Plan by Dick Ellis, seconded by Scott Delzer. Motion carried.

President Danny Brown explained the reasons for calling Deacon Koren Lindley as Deacon of Faith Formation and Outreach as recommended by the Call Committee. The compensation package for this position is as recommended by synod guidelines. The 2023 Mission Plan includes this compensation. Motion to approve extending a Letter of Call to Deacon Koren Lindley to serve as Minister of Word and Service as the Deacon of Faith Formation and Outreach and Definition of Compensation, Benefits, and Responsibilities of the Deacon made by Jennifer Briggs and seconded by Tom Farrell. Motion carried. The President appointed Diane Bruns, Lora Ersland, and Wade Briggs to serve as tellers for the written ballot on the call of Deacon Koren Lindley. The results were reported by President Danny Brown. The vote was unanimously in favor of extending the call to Deacon Koren Lindley.

President Danny Brown presented the gavel to incoming president Wade Briggs. President Wade Briggs thanked outgoing president Danny Brown for his service. He also recognized the contributions of Trinity's staff—Lisa Gale, Alex Eykamp and Scotty Emerson. He invited all council members, including the outgoing members, to attend a council retreat on Saturday, February 11.

Overview

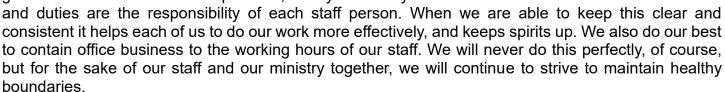

The Holy Spirit is doing awesome things within and among us. God is building something amazing here at Trinity. How cool is it that God invites all of us to be a part of this? Thank you to each and every one of you for all the ways you participate in God's mission here! Thank you for sharing your gifts with this faith community and with our neighbors. You are a blessing to many!

Administration of Office and Staff

All of the ministry we are able to do here would not be possible without our wonderful office staff. They care deeply about the ministry of Trinity and the people they serve. They are committed to doing their jobs well, and are mindful to look for ways we might improve. I am thankful to be a part of such a great team.

In the past year, we have worked really hard to improve our communication – within the office, between the staff and council, and to the congregation. As a staff, we have talked about being mindful of everyone who might be impacted by a decision, so we can share that information with all those involved. News and updates are made available to the congregation through a variety of resources. We recently made some modifications to the weekly eNews to make it more reader-friendly and helpful for those who rely on that resource. There is still much work to be done in the area of communication, and this will continue to be a primary focus in 2024.

In addition, we have been making an effort to set and maintain good boundaries. As much as possible, we try to identify which tasks



The financial deficit Trinity has faced in 2023 has presented the staff with unique challenges. We our fortunate to have office staff who are naturally frugal and resourceful. Together, we have made an effort to reduce expenses in the areas of printing, postage, paper products, and office supplies, among other things. As a staff, we are trying to do our part to conserve our financial resources for sharing the gospel, forming faith, and serving those in need.



Preaching and Worship



In my first year as pastor at Trinity, I made a conscious effort to, mostly, observe the worship practices and traditions of this faith community. There will naturally be slight changes with different worship leaders, but we tried not to make many substantive changes. After some suggestions from, and conversations with, several mission partners and council members, we decided to make some changes to the format of both the Traditional and Celebration services, beginning in the summer. The purpose of this change was to offer two distinct styles of worship so that worshippers with Trinity have options from which to choose. In the Traditional service, we

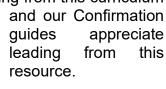
added a cantor to lead the Kyrie and Canticle of Praise. We also began singing, rather than speaking, the Psalm. The Celebration service was modified by removing traditional liturgical pieces and written prayers, and adding in a second song of praise at the beginning of worship and spontaneous prayers.

In the fall, we administered a worship survey to gather people's opinions of the changes, and our worship life in general. Then, in December, we hosted a worship conversation to present the results of the survey and to discuss our response to what we heard. We had a good discussion at the worship conversation, and I appreciate folks devoting time to talk about our worship practices at Trinity.

The feedback we received, both through the worship survey and through other conversations, has mostly been positive. One consistent negative comment we received is that worship services were running too long. Most people want our worship services to last one hour, or less. In response, we have shortened our centering time at the beginning of worship, the message and children's message, and we have worked to tighten up transition times in worship. We have also removed the printed explanations for the scripture readings. Since making these changes, we have been able to consistently keep our worship time within an hour.

Spiritual Formation

Confirmation: We have another awesome group of 6th-8th graders in Confirmation this year! In our three-year rotation, this year is the "Bible year." Deacon Koren and I decided to utilize a curriculum from Augsburg Fortress called, "Colaborate." This resource introduces the students to the holy scriptures in a fun and engaging way. The students seem to enjoy learning from this curriculum







The first half of the year has been devoted to learning about the Hebrew Bible (Old Testament). Students have learned the history of Israel's scriptures. We have talked about how God formed the Israelites and chose them to be a blessing to the world. And, we have reflected on how God has been with God's people through everything they endured – slavery, 40 years in the wilderness, corrupt kings, foreign occupation, and exile. After the Christmas break, we will dig into the New Testament and discover how God was with God's people, in a new way, in Jesus.

We have already had one planned service project for the Confirmation students – *Operation Christmas Child*, through *Samaritan's Purse*, and we plan to have a couple more group service projects throughout the year. Thank you to our awesome Confirmation guides, who faithfully give their time, energy, and passions to help our students learn and grow in their faith! We could not do what we do in Confirmation without their help.

 High School Youth Group: Each Wednesday, a wonderful group of high school youth makes the choice to get together to grow in their faith and build relationships with their peers. We share what is going on in our lives. We pray together. We reflect on God's Word. And, we create opportunities for joy and laughter. This group inevitably lifts my spirits and I see the light of Christ in each and every one of them.

During the summer months, we had several fun outings with this group – an outdoor movie, a service project, and a trip to Wild Water West. Then, in the fall, we took a group to Air Madness and had a fantastic time! We also had a trip to a corn maze scheduled at the end of October, but it got canceled because of SNOW.



Our two biggest concerns with the high school youth group are trying to find times for activities when the youth already have so many things going on in their lives and finding adult volunteers to help with these activities. We would gladly accept assistance from any of our adult mission partners who would like to spend time with some amazing young people. A special thank you to Jennifer Briggs for all she does for our high school youth!

- *Men's Ministry*: The men of Trinity have several opportunities to gather together and build one another up, as men of faith. The Friday morning Zoom Bible study continues to have a faithful group, committed to coming together to study God's Word and apply it to their lives. In addition, our monthly men's gathering on the 2nd Sunday of each month has been going for about a year now. A few months ago, The Office in downtown Madison decided they would no longer be open on Sunday evenings, so we had to try out different locations. We have not, yet, settled on a regular meeting spot. Sometime in 2024, I am hoping to take a group of men to an off-site retreat for a faith formation experience with even greater depth.
- Lenten Book Study: During the Lenten season, as a congregation, we read together the book
 Bless the Lent We Actually Have by Kate Bowler. We had an online discussion group, at
 Wednesday evening worship, Deacon Koren offered a reflection from the book, and I shared a
 Sunday morning message based on the theme of the book. This was a helpful resource for us
 to utilize to focus our Lenten journey.
- Summer Book Study: In the summer of 2023, a group of us read and discussed the book Sacred
 Pulse by April Fiet. In this book, Fiet offers an alternative to the frantic, exhausting way of life
 that most of us are living today. "The Sacred Pulse" shares wisdom and insight, as well as twelve
 practices to employ, to help us enter into a more life-giving rhythm of being. This was a wonderful
 time of discussion and reflection, over the course of eight weeks.
- Advent Book Study: For Advent this year, we chose to read the book Surrender to Love by David G. Benner. This group has had a wonderful time talking about God's unconditional love for us, sharing how we have experienced God's love in our own lives, thinking about how we might know God's love more fully. I think this book and the discussion was a great way to prepare ourselves in this Advent season.

Pastoral Care

I am blessed to have the opportunity to provide pastoral care for the mission partners of Trinity and others in the community. It is an honor to hear your stories and to lift them up to God in prayer. Thank you for entrusting me with this role. In the past year, the number of people in need of regular pastoral care has grown dramatically. I do my very best to keep up with this without neglecting my other responsibilities in this call. A priority for 2024 will be to form, train, and empower a Care Committee to help provide pastoral care for the congregation.

Outlook

In his book, *A Long Obedience in the Same Direction*, Eugene Peterson writes, "Joy is nurtured by anticipation. If the joy-producing acts of God are characteristic of our past as God's people, they will also be characteristic of our future as his people. There is no reason to suppose that God will arbitrarily change his way of working with us. What we have known of him, we will know of him. Just as joy builds on the past, it borrows from the future. It expects certain things to happen." As we move into a new year of ministry together, let us do so with great expectation – trusting that God will persist in God's faithfulness; that God will continue to bless the people of



Trinity, so that we might be a blessing to others. Let us enter into this time with audacious anticipation – watching for the amazing things the Holy Spirit will do among us.

FOUNDATION COMMISSION ANNUAL REPORT – 2023

The purpose of the Trinity Lutheran Church Foundation is to help fulfill the mission of Trinity in all of its activities. The duties and responsibilities of the Foundation Commission are set forth in Trinity's Constitution and the Foundation's policies and procedures, and include the following: (1) to receive and acknowledge all gifts received by Trinity that are not designated for current operations or other special fundraising efforts, (2) to invest, manage and disburse all gifts and managed funds, (3) to encourage the giving of special gifts; (4) to provide annual education about planned giving and estate planning and (5) to celebrate gifts given through recognition programs developed by the Foundation.

The Foundation Commission manages several endowment funds and uses income from these endowed funds for benevolent purposes to further Trinity's missions and ministries. In 2023, the Foundation approved the following uses of income from the endowment funds:

- The Faith In Action Endowment Fund is to assist many ministries within Trinity and other areas.
 - \$ 1,500 for a council retreat in February
 - \$ 2,650 for funding for Deacon Koren and Alicia Koch to attend IF Gathering Conference in Fort Worth, Texas
 - \$ 450 for the youth to make tie blankets
 - \$ 700 to purchase additional worship banners for our worship space
 - \$6,316 to help cover expenses taken from the Cornerstone Reserve fund
 - \$1,000 to Bethel Lutheran Home for purchase of dining room chairs
 - \$ 745 to Days for Girls Madison for purchase of supplies
- The <u>Camp Counselor Scholarship Endowment Fund</u> was not awarded this year due to no congregational members meeting all of the requirements set up for the endowment.
- The <u>Edwin Hanneman Missionary Endowment Fund</u>. This fund continues to provide support for missionaries working with the ELCA Division of Global Missions. The generous gift of Mr. Hanneman through his estate allows our congregation to support God's work through these missionaries. The missionaries we supported for 2023 were Pastor Stephen Deal (Costa Rica); Willie Langdji (West Africa). for a total of \$7,702.00
- The Hazel Johnson Mission Endowment Fund.
 - \$1,200 of Hazel Johnson Endowment Fund was awarded to Mark and Rose Jensen for their work with translations of the Bible.
 - \$1,263 for Kids Against Hunger project
- The <u>Seminary Scholarship Endowment Fund</u> awarded \$1,363 to Wanda Biel who is currently studying at Wartburg Seminary and serving as a Vicar at St. John in Ramona and Oldham Lutheran.
- \$540 of income from the **Rasmussen Organ Maintenance Fund** was transferred to Trinity Lutheran Church to offset some of the expenses of maintaining our beautiful pipe organ.
- The Ellsworth Family Building Fund Endowment expended \$671 towards church repairs.

• The Board of Trustees and Church Council received \$2,821 of income from the **Cornerstone Endowed Fund** to their Cornerstone Fund for use for capital improvements, major repairs, equipment and any other physical needs of the facilities owned by Trinity Lutheran Church.

Total Endowment Spending: The total for all endowment earnings that were awarded for this year to benefit Trinity and other missions was \$28,966.

Endowment Balances. As end of the year statements had not been received as of the deadline for this annual report, the following endowment fund balances were under Foundation management as of September 30, 2023. The spending policy for each of the endowments were established in 2005 or at the time the endowment was received by the Foundation. The spending policy specifies that only the earnings shall be used not the principal amount. The balances have not been adjusted for the current year expenditures since they will happen in quarter 4 of 2023.

The Total Current Assets of the Trinity Lutheran Church Foundation as of 9/30/2023 are \$859,579. Total Current Assets as of 12/31/2022 were \$774,466.85.

Additional future assets of the Foundation include one life insurance policy and two certificates of deposit. These future assets had a market value of \$12,817.28 as of September 30, 2023.

Trinity was remembered with many memorial gifts during the year. A total of \$15,335 as of November 1, 2023 was received. The "I Am In" campaign and Campership received several gifts. If memorials are not designated by the donor for a specific project, they are distributed according to the Foundation distribution policy that gives the Cornerstone 50% of the gift, 25% to the Deacons and 25% to the Parish Education programs.

The Foundation endowment funds would not exist without the generous gifts that have come from our members. Our Legacy Leaders plaque in the Narthex recognizes those individuals (1) who have left a gift to Trinity through their estate, (2) individuals who have notified the Foundation that Trinity has been included in their estate plan, or (3) individuals who give a gift of \$1,000 or more to one of the Foundation endowment funds. We do encourage <u>everyone</u> to consider including Trinity in your own estate plan. Members considering a gift should consult with an attorney or financial advisor for personal financial advice.

The Foundation held their annual education event on Sunday, November 19, 2023 when Kathy McHenry of Lutheran Planned Generosity shared the message during worship and conducted a minisession during the coffee hour. Thank you, Kathy, for sharing your gifts with Trinity.

2023 TRUSTEE ANNUAL REPORT

"SHARING GOD'S WORD, DOING GOD'S WORK"

January 2023 — Trustees contacted the a few flooring companies in town to get bids for the kitchen floor. The tile was cracked and was becoming a hazard.

The Furnace in the preschool and office was having problems keeping the rooms warm. Trustees reached out about a new furnace that was on the roof of the office/preschool addition. We also had to get a quote for the cost of the crane to lift the unit in place.

February 2023 - weather canceled meeting for February.

March 2023– New printer was received in January, a motion was made that the Preschool paid the church 60 dollars a month to help pay for the lease of the new printer plus use of paper and ink used. The accounts are billed by specific code used with the printer.

A discussion was started for a contracting screen and projector to use during services for music, prayers and reading. This would take place of bulletins, reducing paper waste. Sid worked on getting bids for a new furnace for the preschool and offices.

April 2023– One quote for the heating unit was received for a new unit, trustees are waiting for one more. Eric was working on getting the 2nd quote.

Started talking about Stewardship and getting a subcommittee together to brainstorm different ideas. Walker will be the Stewardship chair of the committee.

May 2023-

- Walker Ruhd as a part of the Trinity stewardship activities will be leading a Financial Peace University workshop. This is a Ramsey Solutions created workshop. The workshop will run for 9 weeks and the cost will be \$80 per couple. The council will support scholarships for those who need the financial assistance. The first session will be held at 6:00 pm on the 15th of June in the fellowship hall.
- Eric Anderson and Sid Gilbranson have been working with Timmer supply and Amert Construction on securing bids and scheduling of a crane for the installation. Eric will be working to obtain a second bid.
- The Trinity preschool made a request that the divider in the pre-school room be removed. The consensus of the council was that this could happen.
- A discussion on some type of projection in the sanctuary was discussed.

June 2023– there are no notes for trustees.

July 2023 - No report for July.

August 2023– We mailed out thank you notes were sent out to the people that contributed to the "I am In" campaign.

Fall clean up for the church was discussed and a date was set for August 19th, 2023.

Stewardship committee met and they decided to use the theme "Trinity "in it" Together.

Walker gave an update on the upcoming events:

Temple talk- Sunday, August 13th, Table tents with talking point of what is stewardship, Time and Talent survey coming out in August.

Eric gave an update on HVAC system. Bid from Amert construction was accepted as the new unit will fit the old spot. Don is working with Sid to get it ready to install.

September 2023– Eric was working with Scotty on getting a date set to get the new heating unit installed before it got cold.

October 2023– Working on Mission plan for 2024. Trustee were working on the minor repair and checking into TEAMS phone system, to see if it could save some money.

Insurance for wind and terrorist attacks was discussed. It would be an additional 3256.23 a year. This was rejected by the council.

Heating unit was installed in October.

Stewardship will be doing a 30day prayer request. This will consist of a new prayer each day for different areas of our church and our community.

November 2023– No report was submitted. All trustees were present. Discussion was the heating unit in the entry way of the church, the pump is bad.

December 2023 The ceiling in the balcony is falling down, Amert thought the plaster was separating from the ceiling. 3 businesses were contacted to come look at it (Verchow, Amert's and Brett Pierce with Pierce Construction construction). Brett returned the call. He could come right away to look at it and start the job right away. He was able to get it done before Christmas services. Custodian and Maintenance position was discussed. The decision for the position was to hire one custodian/maintenance or two separate positions.

January 1st, we had the Lake's cleaning service start as a temporary service for now.

Kesteloot construction helping with snow removal for the church until a maintenance person can be hired. If it snows over 2inches, he will come, if we need him for a funeral or wedding we can call. We also have Sam Johnson as a back up for snow removal.

Stewardship – letting the season of giving present itself.

Next meeting, we will discuss some of the programs that were found on the internet to see what best fits our needs at Trinity.

The cost of the firewall for our computer service is increasing \$25/monthly upgrade. New cost will be \$125 a month for the next 2 years.

Walker talked to Joel Brick about the digital sign that doesn't work right now and to get it working he thinks that Daktronic will have to come out to look at it which will cost \$1500. Then it will cost for repairs and taking it down and putting it up again if it can be fixed. It will be tabled until it is nicer out. Joel recommended Barger's to take it down since they have a telehandler.

Tom asked Katie how much was spent on cleaning products from Hillard, year to date (November) \$1800.

Walker did some inventory on cleaning supplies and printed off safety data sheets for future custodians.

Life and Growth

Coffee Hour was held throughout the year with Family Service Groups providing the treats and serving. During the school year Coffee Hour was held between the two services and after the service for the summer schedule. With the new flooring installed in the Fellowship Hall kitchen in June, Coffee Hour was held in the church Narthex for that time and then continued to be served in the Narthex through October as well as serving in the Fellowship Hall. With lack of interest and participation, the coffee serving in the Narthex was discontinued at the end of October.

All Family Group Leader letters were mailed the month prior to the group serving to allow time for planning and an additional request for finding Greeters for each service was added, this was a good fit for each group, needing only Greeters one month during the year. February kicked off our Lenten Season with Soup Suppers beginning Ash Wednesday, February 22nd. Mother Nature had different plans with a full-blown blizzard canceling all activities for the evening. Lenten Soup Suppers continued in February and March with Confirmation students contributing cookies and bars for dessert at the meals. The Trinity cooks did not disappoint with a wide variety of different, delicious soups.

A reception was held in April during coffee hour with cake served honoring Deacon Koren for her installation. In May we honored our high school graduates on Senior Sunday celebrating with cake during the coffee hour.

Mission Momentum

Our worship services were again videotaped this year and we saw declining members attend Sunday services. It is our hope they were able to view our services at home. We want to thank Kaden Krusemark and Bob Gale, and others who may have filled in, for their service to Trinity in 2023.

We identified a specific mission for each month of 2023, and they were:

This joyous offering goes directly to the Mission of the Month and allows children to be included as servants in the Mission.

On August 28th, we served 227 carryout meals at The Gathering. This year we prepared the meals rather than have it catered, which helped to reduce the overall cost of this Mission.

Sacraments and Services

Amber Johnson was elected as the Deacon of Sacraments and Services at the January annual meeting. She resigned her position in September. But in her time in the position, she purchased new home communion kits, put together the Loafer Schedule for July 2023 to June 2024, and oversaw the monthly home communion program. We want to thank Amber for her service this year. This section of the Board of Deacons focuses on three areas. They are:

Home Communion

We have five members who receive home communion on the third Sunday each month. Our volunteers are: Tom & Joyce Farrell, Jim Iverson, Ron & Bobbie Janke, Nancy & Roger Moose, and Susan Williams. Referrals for home communion are given to the Deacon of Sacraments and Services who contacts the individual to have their permission to be on the home communion list. Each of our members is called on the second week of each month to check on their health status and see if they want communion brought to their home on the coming Sunday.

"Loafer" Program

We have eight volunteers who take a month and bake home made bread (using a special recipe) for the Holy Communion services that will be in that month – the first Saturday evening service, and the services held on the first, third, and fifth Sunday of the month. Once the bread has been baked and prepared, the volunteer places the bread in sealed bags, dates the bags, and places them in the kitchen freezer until they are needed. We want to thank our faithful volunteers for their dedicated service! The Deacon of Sacraments and Services puts a schedule out covering the period of July – June, which also lists the worship dates when communion will be served, including special worship dates for Christmas, Lent and Easter.

Pulpit Supply

When Pastor Steve is going to be away from a worship service (vacation, illness, etc.) he will either contact the SD Synod Office for a visitation pastor or notify the Deacon of Sacraments and Services which services he will be gone. This past year, Tom Farrell and Nancy Moose provided pulpit supply, and Jim Iverson and Becky Brown served as worship leaders.

A special thanks to Lisa Gale who lines up the ushers, lectors, and communion assistants who are needed to make our worship services possible. Thanks to each one who is faithful in serving Trinity in these areas of need when she calls for help! It takes faithful people serving in many capacities to provide for the wonderful worship services we have at Trinity.

ANNUAL REPORT FOR TRINITY LUTHERAN PRESCHOOL 2023

Trinity Lutheran Preschool is staffed by Beth Himley, who is in her third-year teaching at Trinity Lutheran Preschool. The preschool hired a new assistant teacher in January, Cara Bender.

The children who were enrolled in the January through May sessions discovered polar animals, experienced Valentine's Day with edible play dough, how to stay healthy, and dinosaurs! For the Spring fundraiser, the students sold Papa Murphy's pizza and Cold Stone Creamery ice cream. The fundraiser was very successful and well liked. The preschool had their own butterflies that the students could watch 5 butterflies metamorphosize. Students also planted their own pumpkins and created a garden by the playground. The students had their spring concert at the end of April and did a terrific job! We also had LOTS of snow days this winter. The classes' last days depended on how many days they missed due to the bad weather. Most of the classes last days were at the end of May.

School began in August with 61 children enrolled. There are 32 students in the MWF classes and 29 in the TTH classes. Miss Beth started the year out on maternity leave, but the school was blessed to have Shari Groen and Alicia Koch substitute until she came back in October.

In September, the students learned about fall and made fall leaves out of their handprints. They also enjoyed watching their pumpkins grow that they planted in the spring. In October, the classes took part in Fire Safety month. Fire Chief Randy Minnaert came to the preschool for the TTH classes and showed them the fire gear and a fire engine. The MWF classes were able to take a field trip to the Fire Station. The preschool also completed their third fundraiser with Gaylen's Gourmet Popcorn from Madison this fall. In November the students learned about the first Thanksgiving and why we celebrate Thanksgiving! In December, the children learned about their five senses and why we celebrate Christmas. The students also got to participate in a gingerbread cookie taste test. The students decorated their gingerbread man and then decided if they liked the taste of their cookie or not. The MWF classes visited First Interstate Bank and First Bank & Trust to sing Christmas carols for their parents and patrons. The purpose of Trinity's women reads as follows:

"As a community of women created in the name of God, called to discipleship in Jesus Christ and empowered by the Holy Spirit, we commit ourselves to grow in faith, affirm our gifts, support one another in our callings, engage in ministry and action, and promote healing and wholeness in the church, the society and the world."

All women of Trinity are included in the organization. We have circles that meet monthly for Bible study and fellowship and hope that Covid does not return to prevent our meeting as it did before.

Three Gatherings are normally held by the Medary conference. One in the Spring, Fall and early winter. Also the Annual meeting is during the year usually in the summer was held this year.

The efforts of the women of Trinity are the Mission Action projects. In 2023, there were many quilts made by our quilters. Several of the quilts would have been sent to Lutheran World Relief. Many were given to the Trinity high school seniors. Indian Missions received some quilts. Moreover personal care kits and school kits were sent to LWR. Also Christmas boxes were sent to McCrossan Boys Ranch. A huge Thank You is owed to all of those who contributed funds, shopped, sewed and packed and especially Lisa Gale for the tremendous job she does purchasing items needed to make these projects successful. Monies raised by Mary circle are given monthly to local non-profit organizations plus at years end larger sums are given to local and state organizations.

Organizations receiving money were staff gift, food pantry, the gathering, Bethel Foundation and the Domestic Violence Network. Details are in the treasurers report. Also check the treasurer's report for amounts sent to each project.

Total number of quilts sent 189, total number of personal care kits sent 92, total number of school kits sent 108. Total number of items sent 289.

I am IN CAPITAL CAMPAIGN REPORT

".. God loves a cheerful giver." 2 Corinthians 9:7

In February of 2018, with the blessing of the congregation at the Annual Meeting, we embarked on a \$1.5 million Capital Campaign to address the estimated \$1.6 million dollar building repairs we were facing. This was an opportunity for Trinity's family and friends, near and far, to respond to God's abundant generosity by making financial commitments over the next five years.

The Trinity faithful answered the call, pledged, and gave generously. We are forever grateful for your generosity and commitment to the Capital Campaign. We have finished the 5-year campaign and 99% of the total dollar amount pledged with the addition of non-pledge & anonymous cash gifts. To date there is a balance of \$147,169 in pledges yet to receive, with \$7,730 in forgiven pledges. By the numbers – we received 244 pledges and gifts from our faith family. We had 125 fulfilled pledges + 38 gifts above their pledge; 72 non-pledge /anonymous cash gifts; and have 66 ongoing pledge payments and 7 zero-payment pledges.

At the beginning of 2022, our Mission Investment Fund (MIF) construction loan was paid off by restructurin the outstanding balance by using \$45,000 of Cornerstone savings, \$45,358.63 from the Tommerassen Estate investment, \$100,000 of Parsonage CDs, your generous principal only gifts, special offerings, memorials, and *I am IN* pledges.

The Parsonage monies were treated as an internal loan, whereby the Church would pay interest on the loan at 4% per year until paid. In 2022, we aid \$40,000 plus a \$4,000 interest payment to our internal loan. In 2023, we continuted to receive pledges and gifts and were able to pay an additional \$45,143.47 to our internal loan. To date, \$85,143.47 has been repaid and is currently invested in 8 liquid CD's making 4.5% interest (split into 7 - \$10,000 and 1 \$15,143.47 CD).

Bethel Lutheran Home, Inc. – 2023 Congregation Report

Since Bethel Lutheran Home opened its doors on March 25, 1962, we have had the amazing opportunity to serve thousands of residents as an extension of your Church. You continue to bless us with good people, both by electing excellent delegates and by referring friends and family who need our services. We are so grateful for all that you do for Bethel Community!

Our 62nd annual corporation meeting is scheduled to be held on January 22, 2024, at Trinity Lutheran Church, to review the fiscal year end 2023 audited financial statement for Bethel Lutheran Home, Inc. January will now become our new Annual Meeting date due to the complexity of our audit as well as the time it takes Casey Peterson to complete the required documentation.

I want to take a few moments to thank everyone for their renewed service to Bethel and our mission in Lake County. Your generous gifts, both monetary and valuable time, have made a dramatic improvement in the lives of the Residents, staff, and our "Community". Every one of you has profoundly impacted our lives and I truly want to say "Thank You" from the Bethel Community.

Staffing Impact at Bethel

Staffing remains the one of our largest challenges ending 2023 and entering 2024. Locating, hiring, and maintaining normal staffing has remained a challenge. However, by the end of 2023 we have seen a dramatic increase in applications as well as new hires which has led to a reduction in Agency staffing needs. We have had 5-6 open CNA positions since March 2021 which we have filled 50% of these openings the end of 2023 alone. CMS requires nursing facilities to maintain specific staffing levels. If the facility misses this benchmark, CMS can impose monetary penalties. To combat this, we utilize Agency staffing to fill open positions to maintain a census and provide quality care. The problem this presents is we must pay temporary staffing companies approximately 50% more than we are able to pay our full-time and part-time staff.

Decreased staffing numbers also affect the number of residents that we can effectively provide care for. Currently our census is on average 54 residents or 91% occupancy. It is important that the quality of care should not be compromised to keep Bethel full. We will increase census as staffing allows. Bethel is among the top 10% of Long -Term Care facilities in South Dakota based on census, most facilities at this time average a 75%-85% occupancy.

Operational Updates

Bethel's revenue had a small decrease in revenue \$6,232,669.59 compared to \$6,632,460 in 2022. Our Profitability, Activity and Efficiency (Return on Capital Employed) ratios have all decreased due to our Agency staffing as well as current inflation rates. Of note, thanks to our South Dakota Legislature our profitability has increased in July 2023 due to the passing of the Medicaid Increase to 100% methodology. Working capital or the time to collect payments was 13.63 days in 2022 currently we are at 13.00 days in 2023.

Capital Improvements

The roof over the Bethel Home needs to be replaced as was stated in the 2021 report with a cost of approximately \$300K. Bethel applied for a grant to replace the existing HVAC system with an upgraded filtration system that will be compliant with new air quality standards and was awarded \$251,912. The contract was awarded to Barger Electric with the project beginning September 2022 and this project ended in September 2023. Bethel now has a new HVAC system as well as each room now has its own "fresh air" return. We have added (4) reverse flow isolation rooms for respiratory illnesses if needed.

Technology Improvements

• In 2023 we did not improve any technology assets as Bethel was in a good position. In 2023 we dramatically improve our Cyber Security posture through a grant received by DSU to assess and

mitigate Cybersecurity concerns. Thanks to a grant through DSU we implemented a new VPN, Multi-Factor Authentication software among many other safeguards to ensure our resident information is secure. This grant will allow for our system to be actively scanned and defended by local vendors in Madison as well as the State of South Dakota. These services will be paid for in the year 2023 and potentially going forward depending on continued Federal Grant Funding.

- We installed a new PA system to allow for facility wide communication as our old system is no longer functioning and not able to be repaired.
- We upgraded our Camera Security system by purchasing a new server as well as a new camera by the employee entrance. This system was over 10 years old and not able to be upgraded due to age.

Additional Updates for FY 2023:

• Thanks to a very strong push in this legislative session a 24% increase and rebase for Nursing Home Medicaid reimbursement passed which equates to a 100% reimbursement based on the current model. The new reimbursement will help alleviate some of the financial burden while potentially helping with recruitment and infrastructure needs.

Star Rating

Bethel Lutheran Home currently has a 3-star facility rating. Five stars is the highest rating a
facility can achieve. This rating is a snapshot in time of a nursing home's quality measures,
which include infection rates, our ability to take care of our residents' pain levels, and
quarterly staffing levels and annual survey results. In April 2019, CMS changed the criteria
of its rating criteria which resulted in over 70% of nursing homes in the U.S. dropping a star
rating.

Overview of challenges facing Bethel

- CNA turnover rates and competition with staff agencies. Currently we pay a single Agency CNA at a significantly higher rate than our "organic" staff. This is a non-sustainable model; we are in drastic need for CNAs in Long-Term Care.
- Capital improvements Bethel is getting older, and several updates are needed.
