

## Deacon's Discourse

"So then, just as you have received Christ Jesus as Lord, continue to walk in him, being rooted and built up in him and established in the faith, just as you were taught, and overflowing with gratitude." ~ Colossians 2:6-7

January has a way of making us think about starting fresh. New calendars. New plans. Maybe even a little pressure to do better or be better. But winter, especially in South Dakota, has a way of slowing us down and changing our expectations.

Paul writes, *"Just as you have received Christ Jesus as Lord, continue to walk in him."* I love that word "received." Our faith begins not with what we do, but with what God has already done. Grace is not something we earn by trying harder, doing better, or getting it right. It is given freely, again and again. Before we take a single step, before we make a single promise or plan, God has already claimed us and called us beloved. We don't walk in faith to earn God's love—we walk in faith because God's love has already been given. We only need to receive it.

In January, the ground is frozen. Nothing looks like it's growing. And yet, beneath the surface, roots are doing important work—stretching deeper, finding nourishment, holding steady. That image feels especially true for faith. God is at work in us even when we don't feel particularly productive or inspired. Being rooted in Christ means we are held by something stronger than our motivation or energy.

Paul goes on to say we are *"rooted and built up in him."* That kind of growth takes time, and at Trinity it often happens in simple, faithful ways. It happens when children gather around Bible stories and songs,

when youth ask honest questions, and when adults keep showing up for worship and conversation. It happens through shared meals, serving our neighbors, praying for one another, singing together, and learning side by side across generations. None of these things earn God's love—but they are places where God is already at work, strengthening our roots and building us up together as the body of Christ.

Finally, we read this beautiful phrase: "overflowing with gratitude." Gratitude doesn't come from having everything figured out or from life going exactly as we hoped. It grows when we begin to notice where God is meeting us—in familiar routines, in shared laughter, in prayers spoken and unspoken, and even in the midst of uncertainty. Gratitude shows up when we recognize that we are sustained by grace we did not earn and carried by a community we did not create on our own. It is a quiet thankfulness that flows from being rooted in Christ, trusting that God is faithful, present, and at work among us—today and always.

So as we begin this new year, maybe the invitation isn't to rush or reinvent ourselves. Maybe it's simply to stay rooted. To trust that God is growing something good in us—often in ways we cannot yet see. Rooted in Christ. Growing in grace. Walking together into whatever this year may hold.

Due to inclement weather, the December 9, 2025, meeting of the Church Council was convened on Zoom.

President Kurt Christiansen led the Council in reciting Trinity's mission statement.

Voting members absent: Dani Ruhd—Board of Faith Formation

Non-voting members present: Darrel Presuhn, Marie Millage, Ben Kapelle

President Kurt Christiansen called the meeting to order at 7:02 p.m.

Vice-president Virginia Lemme conducted the devotion from Luke chapter 1, encouraging everyone to be like Mary who accepted her mission without question. Pastor Steven Lindley opened the meeting with prayer.

Pastor Steven Lindley requested that an item regarding his housing allowance be added to the agenda. Motion by Past president Tom Farrell, seconded by Vice-president Virginia Lemme, to add the housing allowance to new business. Motion carried. Motion by Past president Tom Farrell, seconded by Eric Anderson, to accept the amended agenda. Motion carried.

Motion by Patti Weber, seconded by Past president Tom Farrell to approve the minutes of the November 11, 2025, Council meeting. Motion carried.

## FINANCIAL REPORT

Past president Tom Farrell gave the Financial Report. The general offering received in November was \$41,883.75. Yearly to date statistics include the general offering received totaling \$299,771.08 and expenses, including the bat mitigation, totaling \$376,750.09.

Past president Tom Farrell presented a report on the status of the Hannemann Fund.

President Kurt Christiansen spoke to the congregation during Sunday services on December 7, 2025, bringing them up-to-date on Trinity's finances. An item on the finances will appear in the December 18 e-news.

Motion by Eric Anderson, seconded by Vice-president Virginia Lemme, to acknowledge the Financial Report. Motion carried.

## REPORTS

Pastor Steven Lindley reported:

- This is a busy time for the staff as they are planning Advent and Christmas services and preparing for the annual meeting.
- There have been no new applications for the custodian's position since October.
- Staff evaluations have been completed as of December 4, 2025.
- The Hanging of the Greens service went well. He thanked everyone who participated.
- The Board of Deacons has made arrangements for the service on Sunday, December 28.
- The High School youth continue meeting. They are using an electronic Advent calendar this month.
- The lectionary study group and the men's fellowship are not currently meeting due to low attendance.
- He reported that he had 7 visits during his second scheduled visitation week.
- There has been a marked increase in hospitalizations and health issues among Trinity members recently.

Deacon Koren Lindley submitted a written report adding that she is preparing for the Kids' Christmas service which will be presented during the 11:00 a.m. service on Sunday, December 21, 2025. The date for Bingo Bash has not been set pending the date selected for the annual meeting.

President Kurt Christiansen reported:

- He thanked everyone who worked on the staff evaluations.
- Thank you messages from Pastor Steven Lindley and Deacon Koren Lindley were received.
- Seven CDs (six at \$10,000 each and one at \$14,347) held at First Bank and Trust matured at the beginning of December. They have been renewed at an annual percentage rate of 3.7%.

Vice-president Virginia Lemme reported:

- Marissa Nussbaum has agreed to fill the position of Youth Ministry on the Board of Faith Formation. The Nominating Committee has nominees for all but one open position. Dick Ellis and Virginia Lemme will address the congregation on Sunday, December 14, to encourage members to consider volunteering to serve on the Council.
- The Foundation has awarded the following grants: from the Faith in Action Endowment
  - \$1,000 to East Dakota Transit for Sunday transportation requested by Jim Iverson
  - \$1,000 to Days for Girls for supplies requested by Arleen Weerheim
  - \$750 to Gideons International for new testaments requested by Dennis Larson
  - \$4,250 to the Bethel Home for a wheel chair scale requested by Jona Schmidt
  - \$650 for Christmas Go Box supplies requested by Diane Bruns
  - \$1,000 to Trinity Preschool for a computer and software requested by Beth Himley
  - \$774 to the Trinity Altar Guild for banners requested by Lana Johnson
  - \$1,099 to Faith Formation for Labyrinths requested by Deacon Koren Lindley
  - \$4,250 for chairs for the Fellowship Hall requested by the Board of Trustees
  - \$1,691 for bat mitigation requested by the Board of Trustees

From the Hazel Johnson Mission Endowment Fund

- \$1,737 to the Madison Food Pack requested by Scott Parsley
- Dick Ellis has agreed to serve as the congregation's treasurer.

Board of Deacons—Patti Weber reported:

- The families who will be lighting the Advent wreath candles have been scheduled as has the special music for December.

- Kids' Christmas service will be Sunday, December 21, at the 11:00 a.m. service.
- There will be one service on Sunday, December 28, at 9:30 a.m.
- A service is planned for 10:00 a.m. on Christmas Day.
- The January coffee letters are out. Patti is working with the incoming Deacon of Life and Growth to prepare for the Ash Wednesday soup supper.
- Videographers Maddie Entringer and Kaden Kru-remark will be establishing a schedule for recording Sunday services.
- Trinity's 5:00 p.m. Christmas Eve service will be broadcast on KJAM at 7:00 p.m. Christmas Eve. Cost for the broadcast is \$189.00.
- The benefit of broadcasting the Sunday worship services on KJAM was discussed.
- The Board of Deacons is working on a schedule for the Mission of the Month. They are looking for local causes to support. The Fellowship of Christian Athletes is the Mission of the Month for January.

Board of Trustees—Eric Anderson reported:

- Based on his experience with cellular outdoor cameras, Joel Brick does not think they are the best choice for Trinity. He is planning to speak to Mark Smith about outdoor cameras. Joel has a new DVR that he would be willing to donate to the church.
- Richard Wolf has completed the sanding and painting of the new windows in the education wing.
- The service contract with Century Business Products for the M3504 LDN printer has expired. The machine is old and parts are no longer guaranteed by the manufacturer. A representative from Century Business will be available to discuss options with the staff. In the meantime the service contract has been extended to February 4, 2026.
- The Board has chosen to purchase padded chairs without arms for the Fellowship Hall from Office Peeps at \$75 each. They may also include a few chairs with arms in this purchase. They received a \$4,250 grant from the Foundation for this purchase. The Council discussed how to dispose of the old chairs.
- Snow removal--JS Mowing LLC submitted a bid of \$245 for each instance. They would come automatically any time there is a snowfall of 2 inches

## OLD BUSINESS

President Kurt Christiansen thanked the Boards for their work in completing the proposed Mission Plan for 2026 and presented the 2026 Mission Plan for discussion. Changes to the proposed Mission Plan included adding \$2,600 for the broadcast of the Sunday Service on KJAM back into line 6140.10; change the requested amount in line 6270.12, Campership Expense, to \$1,500; change the request for Utilities, line 6340.00, to \$14,500; reduce the request for Auto Expense (Mileage), line 6410.00, to \$2,000; increase line 6820.50, Custodial Wages, to \$18,000; change anticipated general offering to \$375,000. Following additional review and discussion of the proposed 2026 Mission Plan, Past president Tom Farrell moved to table consideration of the proposed Mission Plan to 7:15 p.m. on Monday, December 15, 2025. The motion was seconded by Vice-president Virginia Lemme. Motion carried.

## NEW BUSINESS

Motion by Past president Tom Farrell, seconded by Eric Anderson, to set Sunday, January 18, 2026, as the date for the annual meeting with a snow date of Sunday, January 25. The meeting will be held in the Fellowship Hall. Motion carried.

Past president Tom Farrell presented the following changes to the Trinity Foundation's policies:

Changes to the Hazel Johnson Mission Endowment Fund Distribution Policy: 1) Change Recipient Selection to read "The Foundation will publicize the availability of funds. Historically, \$1,200 has been designated annually to Mark Jensen, a Trinity member who works with international Bible translations. The remaining funds are awarded based on applications submitted in October and selected in November." 2) Change Distribution History to read "The Foundation will maintain a permanent record of all distributions made from this Fund."

Changes to Trinity Lutheran Church Faith in Action Endowment Distribution Policy:

1) Add "If there are insufficient requests funded for the amount of income available to be distributed, the Foundation will reinvest the unused funds, and reserves the right to consider an award at any time prior to the next annual request for proposals if a need arises." as the third paragraph of the Recipient Selection. 2) Change Distribution History to read "The Foundation will maintain a permanent record of all distributions made from this Fund."

Changes to the Edwin Hannemann Missionary Endowment Fund Distribution Policy: 1) Add the following as the third paragraph in the History of Fund: "In 2024, following the 25 years, the Foundation Commission and Trinity Lutheran Church voted to return the year's balance of \$202,558 to the Trinity Council to spend as they saw fit. The Trinity Council passed a motion to establish a Tithe Of 10% of the Hannemann gift. On October 15, 2024, the Council passed a motion that the Tithe include \$12,256 to Bethel Lutheran Home, \$4,000 to the Trinity Preschool, and \$4,000 to the Trinity Foundation to return the Edwin Hannemann Fund to the threshold of \$10,000 to continue the endowment. The council action was approved by the membership of Trinity at their annual meeting on January 15, 2025." 2) Change Timing of Distributions to read "The timing of a selection of a recipient of support may vary. Distribution will be made annually, usually in the fall." 3) Change Distribution History to read "The Foundation will maintain a permanent record of all distributions made from this Fund."

Changes to the Trinity Lutheran Camp Counselor Scholarship Endowment Fund: 1) Add the following to Donor Restrictions "Distributions may be made to or on behalf of Trinity Lutheran Church members who are attending college and choose to spend their summer working full-time as a summer Bible camp counselor." 2) Change Distribution History to read "The Foundation will maintain a permanent record of all distributions made from this Fund." Motion by Eric Anderson, seconded by Vice-president Virginia Lemme, to accept the policy changes. Motion carried.

Motion by Past president Tom Farrell, seconded by Eric Anderson, to accept the Engagement Letter for Business Bookkeeping and Tax Preparation from Katie J. Nelson, CPA, Nelson Bookkeeping and Tax, LLC. Motion carried.

The formation of a Church Policy Committee was tabled to the January 2026 Council meeting.

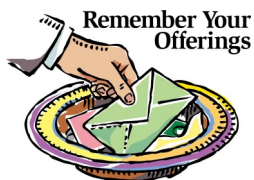

## Trinity's New Vision and Mission Statement and Logo

In 2025, Trinity's Vision Team devoted about six months to praying, listening, and discerning together, and crafting a new vision and mission statement to help inform and shape our shared ministry in the future. At the council meeting on October 14, 2025, Trinity's council reviewed, discussed, and voted to approve the statements. We then asked Trinity member, Courtney Storm, to create an updated logo to correspond with this new vision. She drafted three versions of a new logo, which are bright, colorful, inviting, and meaningful. These logos were approved by the council on December 9, 2025. The new vision and mission statements, and the new logos, will be up for congregational approval at the annual meeting on Sunday, January 18, 2026 at 12 pm. 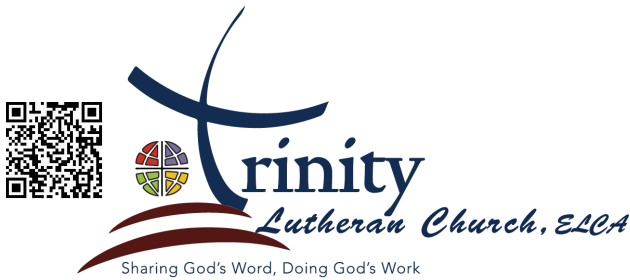
